Listing of Series E Bonds and Series F Bonds

Please be advised that in a letter dated March 28, 2012 which was received by the Company today, the Philippine Dealing & Exchange Corp. ("PDEx") advised that it has approved the Company's application to list its Fixed Rate Series E bonds in the aggregate principal amount of ₽10 billion due in 2019 ("Series E Bonds") and its Fixed Rate Series F bonds in the aggregate principal amount of ₽7 billion due in 2022 ("Series F Bonds") for trading on the PDEx. The Series E Bonds and Series F Bonds have been approved for listing on the PDEx effective April 2, 2012.

The Series E Bonds and Series F Bonds form part of the ₽20 billion fixed rate bonds registered with the Securities and Exchange Commission as disclosed in the Company's SEC Form 17-C dated March 16, 2012.
